

Payment, Cancellation of Registration, General information

Open seminars / courses in Darmstadt and other locations and as live online training

Conditions of payment / Training course fee, Seminar fee

The fee is a net price, applies per participant and is subject to VAT at the applicable rate. The fee includes the course, training documents and confirmation of participation. No confirmation of attendance can be issued to participants with significant absences. Partial participation in a course does not entitle the participant to a price reduction.

For face-to-face seminars in Darmstadt, the use of technical equipment, drinks during breaks and lunch are also included in the price. Travel and accommodation costs shall be borne by the customer.

Cancellation conditions / Cancellation of participation

Cancellation of a seminar must be made in writing. Cancellations made less than four weeks before the start of the seminar will not incur any further obligations, after this time 30% of the fee will be charged, from the last two weeks 80%.

Invoice:

The respective invoice amount is due net immediately after receipt of the invoice, at the latest 14 days after the invoice date

Registration

Due to the limited number of participants, we recommend early, written registration. By registering, you accept our terms and conditions as binding.

Confirmation

We will confirm your registration immediately, but reserve the right to make the final confirmation. If the minimum number of participants is not reached, we will inform you approx. 2 weeks before the start of the seminar and offer you an alternative date.

Training times for classroom training in Darmstadt (often different at other locations)

Training starts at 08:30 on the first day

Training ends at 16:30 on the last day

(unless otherwise agreed / CET/CEST in Germany)

Training times for live online training

Duration per training section up to approx. 2 hours.

Typically 1, 2 or 3 training sessions are held per training day.

Start of training typically 10:00 a.m.

Training typically ends at 12:00 noon

(unless otherwise agreed / CET/CEST in Germany - international times are agreed separately)
